

SMEs Special Transaction Fee Promotion - Terms and Conditions

1. SMEs Special Transaction Fee Promotion ("**Promotion**") starts from 1 March, 2022 to 30 April, 2025 (both dates inclusive) ("**Promotion Period**").
